Sub : Issues of concern for retired Executives.

Dear Sir,

We would like to take this opportunity to congratulate you and your team for getting approval of GoI for the long awaited CIL Executives Defined Contribution Pension Scheme, 2007. However, our concern regarding the Scheme has been brought to the notices of Chairman, CIL vide our letter dated, 1st Aug, 2018. A copy is also enclosed for your kind reference.

Please recall our detailed discussions held on 2nd May, 2018 at your Office on issues of concern for retired executives of CIL (a copy enclosed). Regarding issues other than the above, none of the issues raised have been addressed so far. Our next meeting with you, as promised from your end, is still awaited.

Further, please also refer to our letter dated 18th June, 2018 regarding extending medical reimbursements in non empanelled hospitals, limited to CGHS rates. However, we are yet to get any response in this regard for retired executives, though this has been approved for serving executives.

At present, medical bills are submitted by the retire Executives for reimbursement only quarter-wise, as per directive of CIL. It is to bring to your kind notice that the medical bills for the Jan'18-March'18 quarter, submitted during April'18, are still awaiting payment at CIL. This inordinate delay in payment of medical bills is causing immense hardship to retired executives and is not desirable. Moreover, we the retired executives are finding it difficult to get medical help and assistance in absence of a full time medical consultant, after end of tenure of Dr Ashoke Pramanik. The issue of appointment of a full-time medical consultant may considered on priority.

It is therefore requested that a time slot for a formal meeting may be allotted at an early date, so that we may discuss our issues of concern for necessary redressal.
