Sub : Formation of a Federation of Retired Executives' Associations of Coal India.

Dear Sir,

It is observed that the retired executives of Coal India Ltd. settled at different locations have formed individual association to take up the issues of common interest with the local and outside authorities. While this is fine for solving local issues there are certain issues related to retired executives that require the attention of the holding company and the Govt. of India. Some of the major issues of concern at present are : Uninterrupted payment of pension (CMPS'98), Proper settlement of Additional Retirement Benefit (9.84%) and Review of Medical Benefits apart from others.


As you are aware, CMPS '98 is facing difficulty of fund crunch resulting delay in payment of pension as well as possibility of discontinuance. Addl. Retirement Benefit (9.84%) is yet to take a shape even after a delay of about 10 years. Present Medical Benefits are also not meeting the increased cost of treatment, as well as there is considerable delay in settlement of medical bills.

You may also be aware, that some of the executives retired from CIL Hqts and subsidiary companies settled at different places in India, have formed an Association named "Coal India Ltd Retired Executives Welfare Association (CILREWA)" with a registered office at Kolkata. While we have been taking up issues of common interest with the CIL management, subsidiary companies management and the Govt. it is felt necessary that a federation of all the Associations would add value and strength to the common causes of the retired executives and to ensure favourable and early solution of such issues. We believe that you also would be of the same view.

In the above context, we would like to request your Association, to join the Common Platform (the name of which can be decided later), so that a strong body is formed for finding out solutions for the long pending issues and those cropping up in future.

A line of confirmation from your end will be highly appreciated and pave the way for fixing a suitable date for a meeting at Kolkata for discussing the ways and means of formation of the proposed federation.
