Sub: Meeting with the representatives of Coal India Limited Retired Executives Welfare Association (CILREWA) on 24<sup>th</sup> January, 2020.

It was an immense pleasure in meeting you and all the functional Directors of CIL on 24.01.2020 to convey our gratitude on behalf of the Retired Executives of CIL to the Top Management of CIL for enhancement of the ceiling limit of domiciliary expenses and some other helpful modifications in CPRMSE Scheme. We also thank you and your team for giving a patient hearing to some issues related to the retired executives of Coal India Limited.

Issues discussed were as under:

1. **Status of payment of interest on NPS for delayed settlement:**

This long-standing demand of Executives of CIL was discussed and it was informed that communications has been made with MOC by CIL and is expected to be resolved shortly.

2. **Consideration for super senior citizens:**

Sri N.C. Jha on behalf of CILREWA requested CIL Management to provide for some consideration for the senior citizens, who have attained the age of 75 years, in line with the practice prevailing in some Public Sector Undertakings. The Management advised CILREWA to send a proposal for consideration by the company.

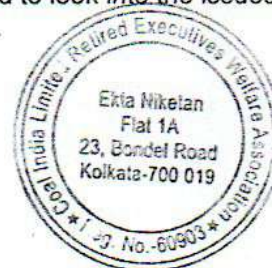
3. **Settlement of CMPF Pension of spouse:**

It was informed by CIL that the matter has already been taken up in the meeting with the CMPF Commissioner and steps would be taken to expedite the issue.

4. **Inclusion in CPRMSE:**

- Provision for reimbursement of medical expenses for Psychiatric Treatment.
- Provision for inclusion of the executives who have served the company for more than twenty years or separated from the company after fifty five years of age provided they are not availing any medical benefit from other companies.

These issues were discussed at length. CIL Management agreed to look into the issues on a positive note.

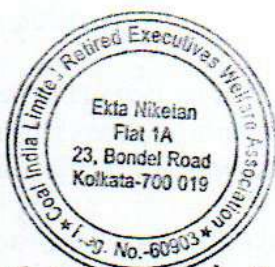
## 5. Reduction of timeline for payment of OPD Bills in CIL and subsidiaries:
