- a) "Payment of NPS interest" has progressed as the MoC had given its approval for payment of interest. This could happen as we did not go for legal option against CIL as per the collective decision of the committee. Payment was expected by June '22 end which is not likely to happen. We have to wait some more time. There is no information about the quantum of interest.
- b) Regarding 'Issue of Spouse pension', even though required data were generated through "Life Certificate" of November 2021, no action has been taken by CMPFO to stream line the issue.
- c) Delay in medical bills reimbursement continues and out-sourcing by CIL for it is yet to finalised. We have requested Dir (P), CIL to follow the return to circular for non-executives to clear the bills within 45 days.
- d) CIL has not taken any action for Enhanced Domiciliary payment for Super senior members i.e. 75 years +.
- e) Revision of CGHS rates was done for some treatments, but consultation fee remains at Rs.150.00. CIL is yet to take any decision for negotiated rate for consultation fee at per with other PSU.
- f) Pending vigilance case at the time of retirement, many retired executives have not been issued medical cards. As a result, those executives are facing extreme difficulty in their family members' treatment. We had requested Dir (P&IR), CIL to complete the vigilance investigations in a time bound manner so that innocents do not suffer. But we are yet to get any response in this regard.
- 3 a) DELIBERATION OF COMMITTEE MEMBER Sri U BHOWMIK: Sri U Bhowmik was requested to inform the General Body about the latest status of NPS interest. Mr. Bhowmik informed the General Body that calculations of NPS interest have been completed by CIL and are being checked by audit team before transferring the corpus to the Trust.
 - b) Voices were raised by some of the members to take a legal course in order to settle the issue of avoidable delay in settlement of payment of interest on NPS by CIL. The Secretary however was of the opinion that we should wait till the actual payment is made by CIL, to have the details of interest applied on yearwise arrival of final amounts. He from experience further said that going for litigation at this
