**Sub :: Non-receipt of personal copies of the Revised Pension
Payment Orders by the concerned pensioners.**

All the retired executives who had earlier received the PPOs in old format, applied (as per the prescribed format along with the required documents) for issuance of Revised PPOs (RPPO), way back in 2023. We have been informed that as on 23.06.2025, out of 18460 nos. of such cases submitted to your office, RPPOs have been prepared only 13457 nos. of cases.

You will please appreciate that the basic purpose of this RPPO has been to ensure seamless and hassle free processing of Widow Pension.

We are , however, quite at a loss to find that a large number of the applicants have not received their RPPOs even after expiry of a long period, while in some cases incomplete RPPOs i.e bearing no signature etc. have been received .As death is an inevitable part of the life , many of them have expired waiting for the RPPOs. Consequently, their widows could not apply for pension as per the procedure laid down in the MoU signed on 31st.March,2022 between SBI & CMPFO and thus the inordinate delay in issuing the RPPOs belies the spirit and intention with which the MoU was signed.

Sub: Request for a meeting with CILREWA representatives.

In continuation of the last meeting taken by you with CILREWA representatives on 5th August, 2024, we have broadly identified the following problematic issues concerning the retired executives of CIL & the subsidiary companies and earnestly seek your kind attention for discussion:

1. Enhancement of Ceiling Limit of Rs 25 Lakhs for treatment of OPD and Hospitalisation expenses.
2. Non-payment of interest to CPRMSE Trust Fund on account of delayed transfer of fund (for the period from 01.01.2007 to 31.03.2018/29.06.2018).
3. Grant of special Ex-gratia to the retired executives aged 75 years and above.
4. Enhancement of Ceiling Limit of Rs 36000/- towards reimbursement of domiciliary expenses.
5. Inordinate delay and improper issuance of Revised PPO by CMPFO in respect of executives retired from the Subsidiaries of CIL.
6. Formulation of Standard Operating Procedure (SOP) by CMPFO for seamless disbursement of spouse pension.
7. Discontinuation of CMPF Pension, in a few cases, in spite of submission of life certificate through online mode in the month of November, 2024.

We would request you to kindly provide us with a suitable time slot from your busy schedule so that the details can be placed before you for appropriate direction on the issues.
